

# TITAN EARTH GRID® 15

BI-AXIAL POLYPROPYLENE GEOGRID



Titan Earth Grid® 15 is a bi-axial polypropylene (PP) geogrid. It is manufactured using a punching and drawing process whereby the polypropylene sheet is stretched in two directions, machine (longitudinal) and cross-machine (transverse). The result is a monolithic and isotropic geogrid with thick and wide ribs, and thick integral nodes. The ribs have a high degree of molecular orientation continuing in part through the mass of the integral node. Engineered to be mechanically and chemically stable in aggressive soil environments, the Earth Grid™ geometry allows for strong mechanical interlock with soil particles and features high tensile stiffness at low strains to resist construction damage, environmental exposure and formulated to resist UV degradation. It is also not susceptible to hydrolysis, environmental stress cracking and micro-organism attack.
